## **Carter Accommodation Ltd Health & Safety Policy Statement.**

Carter Accommodation Ltd Directors and managers are committed to providing a safe and healthy working environment for all workers and for the prevention of work related injury and ill health. In consideration of this commitment we take into account the context and scope of our activities and the specific nature of our OH&S risks and opportunities derived from these, in order to tackle them in priority order; priority being via our commitment to eliminate hazards and reduce OH&S risks wherever possible, while also considering fulfilment of legal and other requirements.

This commitment extends to our staff, all interested parties including visitors, customers, suppliers, sub-contractors and members of the public in so far as they come into contact with our company and related activities.

To this end we have created an OH&S management system which provides a framework for this commitment and includes a commitment to continually improve in our OH&S management and the management system itself.

As part of this framework our management system enables consultation and participation of workers and their representatives, where they may exist. It commits to improving working life for our employees through inspections and audits, setting of objectives in line with business needs, training, H&S committee meetings and deployment of suitable resource to action H&S objectives and safety improvements.

A systematic approach, through our OH&S Management system is used to identify hazards, assess risks and determine suitable and sufficient control measures and the communication of such to employees and other interested parties.

All employees are informed, from induction onwards, that they have duties under the Health and Safety at Work Act 1974 to take due care of the health and safety of themselves and those around them and to ensure that they do not endanger other persons through their own acts or omissions. They are informed that they must co-operate with Carter Accommodation in order that we comply with legal requirements placed upon us and in order to implement this policy.


